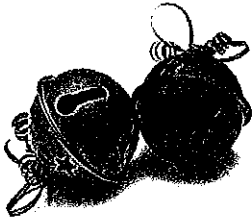

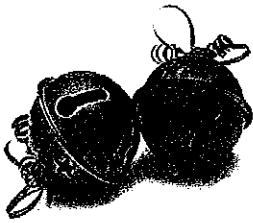

## **2019 FNB Jingle Bell Queen APPLICATION and RULES & REGULATIONS**

1. All interested applicants must submit an application to be reviewed by the Jingle Bell Queen Selection Committee.
2. **Applications must be received by October 26, 2018. Application can be mailed or dropped off at the address listed or through your high school guidance office.** All applicants need to be available in November for interviews and stage presentation.

3. Applicants must be female, at least 16 years of age and no more than 18 years of age, as of January 1, 2019. The committee reserves the right to ask for verification of age.
4. Applicant must be a current resident of Pike County and enrolled in a Pike County school district.
5. Applicant must not have been a previous FNB Jingle Bell Queen. Past court members, excluding prior Jingle Bell Queens, are invited to enter the contest, provided all other qualifications are fulfilled.
6. Applicant must not be married, never have been married, nor be cohabitating with a non-related male from the time entering the contest until her reign on the court ends.
7. Applicant must be of non-parental status from the time of entering the contest until her reign on the court ends.
8. Contestants must be clear of any misdemeanors and/or felonies.
9. **All applicants who are selected for the court must be present at the Jingle Bell Candy Cane Variety Show to be held on November 16, 2018, at Waverly High School Auditorium.**
10. **The 2019 Jingle Bell Queen and court will be crowned November 16, 2018 at the Candy Cane Variety Show. Their reign will not begin until January 1, 2019. Furthermore, the newly crowned court will not represent themselves as such in the 2018 Jingle Bell Luminary Parade or at other 2018 Jingle Bell events, except the luncheon where they will be introduced to other royalty courts on November 17, 2018. There will be 2 final winners: Jingle Bell Queen and Jingle Bell Attendant.**
11. **Judging will be based upon a composite score of communication skills, personality, poise, self-presentation, and knowledge of the weekend and history of Pike County.**
12. All scores will remain property of the judges and NO scores will be given to the Jingle Bell committee, contestants, or parents.
13. No contestant will be allowed to give flowers, gifts, or tokens of appreciation to other contestants, judges, chaperones, or committee members during the judging day.
14. The queen and her court must not be serving as another queen or court member of another festival from the date of entry until her reign is completed.
15. Your entrance and signed application establishes your agreement to all Jingle Bell Queen regulations and guidelines set forth by the Jingle Bell Committee Board and the Jingle Bell Royalty Committee, if you should become a member of the court.
16. Pre-season mandatory meetings will be held to discuss elements of being on the court, proper poise, attire, and etiquette. Queen and court members must adhere to all OFEA rules and regulations.
17. The Queen and her court are expected to uphold a good moral standing, positive attitude, and respectfulness of the event and community.
18. The Queen and her court must be present during the scheduled appearances during the weekend of the 2019 festival.
